Status Management

1 Purpose

Document

Status Management is used to control the state of Projects.

Prerequisites

Before changing the status, user should be confirmed about project status.





1.1 Process Steps (PD Construction)


1.1.1 Created Status (CRTD)

Use

This is the initial system status for new WBS elements; the system sets status CRTD automatically, when you create a new WBS element. This status allows you to plan costs, revenues and budgeting. Purchasing process can also be started from this status like generating purchase requisitions, purchase orders/service entry

Procedure

1. Access "Project Builder" App, From Fiori Launchpad, and Open Respective Project.



Result:

CRTD status generated automatically.






1.1.2 User Status (PRBB / ARAB)

Use

PRBB User Status is set as default in project definition, it will prevent project / sub project status set to release, once Budget is allocated and Budget is released, This status will be set to ARAB so that project / sub-project status will be set to REL, so that Execution of Work can be initiated.

Procedure


1. Click on System Status / User Status Button








2. Choose ARAB Status (Allow Release After Budget)







3. Press Back, now you can view the user status to ARAB from PRBB (Now user will be able to release the project / sub projects)



Result:

User Status has been changed to ARAB, it will allow project system status to Release now.






1.1.3 Released Status (REL)

Use

REL-Released status allows you to post and transfer actual cost to project WBS Element. This status is necessary to receive materials. Activity confirmation, external activity receiving and service acceptance sheet can be done by releasing network activity only which automatically set system status of WBS element as PREL-Partially released. Planned cost from Personnel Cost planning (PCP) can only be transferred to WBS element whose system status is set to REL-Released. WBS element having REL-Released status cannot be changed back into CRTD-Created

Procedure


1. Open "Change WBS Element Status" App and Search for WBS Element.








2. Click on Set System Status, and choose Release option




3. Press Set Option








4. System Status has been set to release of WBS and all WBS under it.








5. Open "Change Network Activity Status" App, select the activity







6. Press Set System Status and choose Release




7. Press Set button








8. System status of network activity has been set to Release



9. View Network activity Detail by opening "Network Activity Overview" App and enter project definition and press GO













10. Choose Activity and press show detail button.


1.1.5 Technically Completed Status (TECO)

Use

Technical Completion (TECO) status represents the physical or mechanical completion of a project or individual asset. Although work may be complete on the project, it is expected that late charges, e.g. final vendor invoices, are outstanding therefore the structure must be open for receiving financial postings. Status will pass on to the subordinate objects as well.

Procedure


1. Open "Change WBS Elemnt Status" App and search WBS Element.







2. Choose Set System Status and and select Complete Technically




3. Confirm the Set option

• This process will be carried out once handing taking has been completed.






1.1.6 Cancellation of TECO Status

Use

TECO status can be reversed for WBS Elements which may be required to plan dates and cost again by changing existing network activities or assigning new activities.

Procedure


1. To Rest the status to REL, Press Clear button.








2. Press Clear option form confirm system status change.

Status has been reset to Release form Technically Completed.






1.1.7 Closed Status (CLSD)

Use

CLSD-Closed status is set for a work breakdown structure or WBS element that has been completed from both logistic and an accounting point of view. It means you can no longer assign networks activities, confirm activities and receive materials/external services. You use this status for a work breakdown structure that has been completed from both a logistic and an accounting point of view.

Procedure


1. Open Change WBS Element Status App, and search WBS Element








2. Press Set system status and choose CLOSE




3. Press Set Option



4. WBS Status has been set to CLOSE.













5. Open "Change Network Activity Status" App, and search for relevant activity for changing status.








6. Press Set system status and choose Close option




7. Press SET option from confirm system ststus popup.

• This process will be carried out once A-90 has been performed along with all invoices has been posted.






1.1.8 Cancellation of CLSD Status

Use

CLSD status can be reversed for WBS Elements which may be required to post vendor or client invoice and service acceptance.

Procedure


1. To Undo Close status, Press Clear Option








2. Perss Clear option from confirm system status change window
