PROCUREMENT OF NON-CONSULTANCY SERVICES

1. The **IESCO-PMU (Islamabad Electric Supply Company (IESCO))** has reserved Funds for the procurement planned for FY **2026-27**. The **IESCO-PMU (Islamabad Electric Supply Company (IESCO))** intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the **“NCB-280 HIRING OF SERVICE PROVIDER FOR PROVISION OF SMS GATEWAY AND INTEGRATION FOR IESCO ADVANCED METERING INFRASTRUCTURE (AMI) PROJECT UNDER ADB COUNTERPART FUNDING”**

2. The **IESCO-PMU (Islamabad Electric Supply Company (IESCO))** invites Bids through **EPADS v2.0** from eligible Bidders registered on **EPADS v2.0** for provision of Non-Consultancy Services.

3. **Single Stage-One Envelope** Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting **Quality and Cost Based Selection (QCBS)** Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, and Instructions issued by the Authority (from time to time).

4. All Bids must be accompanied by a Bid Security described in Bid Security Section in Bidding Document in the form of **Call at Deposit, Bank Guarantee, Demand Draft** or Bid Securing Declaration on the prescribed format described.

5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System (EPADS)** at <https://vendors.epads.gov.pk/>.

6. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through **EPADS v2.0** on or before **Wednesday, July 8, 2026 11:00 AM**. E-bids will be opened on the same day at **Wednesday, July 8, 2026 11:30 AM**. Manual submission of Bids shall not be entertained.
