1. Only E-bids are acceptable, all the interested Bidders are advised to apply through E-Pak Acquisition & Disposal System (E-PADS v2.0) Portal Online at <https://vendors.epads.gov.pk/>. and also upload all the mandatory information as required in the bidding documents.
2. Tenders will be opened on "*Single Stage Two Envelope basis*" through *International Competitive Bidding (ICB) Procedure*.
3. The prices should be firm and final as terms and conditions prescribed in the bidding documents and without involving any foreign exchange.
4. The bid shall be valid for a period of 60 days.
5. The bidder shall submit sealed Bid security/Guarantee in original mentioned against each tender valid for 90 (Ninety) days in the form of Bank Guarantee/CDR issued by any scheduled Bank of Pakistan (having rating A+ or above) in favour of Chief Executive Officer IESCO Islamabad, before the bid closing time, failing which the bid(s) shall be considered non-responsive. In case of foreign bidder, bid security shall be submitted through swift through Pakistani Banks.
6. In case of foreign bidders, the import duties and taxes applicable in purchaser's country shall be loaded for evaluation purpose.
7. All conditions regarding financial soundness, general/contractual experience as mentioned in evaluation criteria of bidding documents.
8. IESCO reserves the rights to reject all bids prior to the acceptance of a bid.
9. In case of holiday announced by the Govt. of Pakistan, strike in IESCO or any other reasons whatsoever due to which this office remains closed on the above schedule tender opening date, the tender will be opened on next working day at the same time and place/venue.
