The tenders will be opened in the presence of participants or their authorized representatives (bearing authority letters) who care to attend the office of Chief Engineer (MM) IESCO Head Office G-7/4 Street No. 40, Islamabad. Material should conform to relevant specifications mentioned in the bidding documents.

Terms & Conditions

- 1) The prices should be firm and final on DDP basis without involving any foreign exchange.
- 2) Tender must be accompanied with Bank Security of Rs.50,000/- as a bid bond valid for 120 days in favor of CEO in the form of bank guarantee / call deposit / demand draft / pay order issued by any schedule bank of Pakistan (having rating A+ or above).
- 3) Tender forms including terms and conditions and specifications/requirements can be obtained from the office of Chief Engineer (MM) IESCO Islamabad against non-refundable amount of **Rs.2000/-** on any working day during office hours till a day earlier from the date of opening of tender.
- 4) The Bid should be for full tender quantity/items and bid for fraction of quantity will not be accepted.
- 5) Written application on company letter head along with copies of registration with sales tax department (STRN), NTN # etc. should be produced at the time of issuance of tender documents / bid schedule.
- 6) No tender will be issued on the date of opening of tenders.
- 7) The bids are valid for ninety (90) days.
- 8) The blacklisted firm by any Govt. Agency is not eligible for participation in the tender. The firm should submit an affidavit stating that their firm has not been blacklisted by any Govt. / Semi Govt. / Autonomous body and no legal action is underway against their firm.
