1. Electronic bidding document containing detailed requirements terms and conditions is available on **E-PADS** at [www.procure.gov.pk](http://www.procure.gov.pk) & [www.ppra.org.pk](http://www.ppra.org.pk) and also available at IESCO website.
2. Bid must be accompanied by a Bid Security duly generated from firms / owner own account and should be in the form of pay order/ CDR in favor of **Executive Engineer Civil Division IESCO**. The prospective bidders shall upload scanned copy of Bid Security on **E-PADS** in PDF format and original CDR alongwith required documents & hard copy of the bid exactly the same which is uploaded on the E-PADS in sealed Envelope **before 01 Hours opening of bid**, in the office of Chief Engineer (O&M) Distb Room No.103 Street No.40 at IESCO Head Office G-7/4 Islamabad, otherwise bid will be rejected.
3. The Firm / contractors already working with this office and they have not completed their works within stipulated period will be treated as **Non-Responsive**. Performance certificate / completion certificate duly recived by xen concerned must be provided by the contractor duly signed by XEN / SDO concerned **must be upload on E-PADS** for consideration as responsive bidder.
4. Pakistan Engineering Council Registration renewed for year 2025-26 with at least **Category C-6** having Specialization Code of **CE-10**.
5. Bidder will provide the fresh (maximum 30 Days older) bank balance of firm upto 50% of estimated cost.
6. Firm / Company successfully completed similar nature of work in any Govt / Semi Govt. organization / Autonomous body successfully handed over to concern Department ( Work order & Completion Certificate must attach).
7. Firm / Company must attach active registration certificate issued by the PRA and FBR with their Bids.

In case of total bid amount is less than 10% below the N.I.T amount the bidder shall submit additional call deposit as performance security equal to the difference between N.I.T amount and total quoted amount less 10% of N.I.T amount the additional performance guarantee shall be submitted along with bid. Bids having rates below 10% of N.I.T without additional call deposit will be rejected.
09. Any Blank document upload by the contractor / firm on the E-PADS consider as Non-responsive.

- a. Presentation of false / wrong documents will be strictly discouraged and their CDR shall be forfeited besides black listing.
- b. Deposit Earnest Money @ 4% of Estimated Cost in the form of CDR in favor of Executive Engineer Civil Division IESCO Islamabad.
- c. The successful bidder shall produce 10% of contract price in shape of pay order / Bank guarantee/CDR performance security before signing the contract agreement.
